Eligibility to be elected as a delegate

For one to be elected as a delegate he/she must fulfill the following:

- (i) Must have been a registered and contributing member of the Society for at least three (3) years prior to date of elections.
- (ii) Shall have attained a minimum of 'O' level certificate of education and demonstrated knowledge of Sacco Management.
- (iii) Must have at least Ksh. 300,000 (Three hundred thousand) in the Society as non-withdrawable deposits, three months prior to the date of election, or as may be set by the ADM from time to time.
- (iv) Shall not be delinquent on loans with the Sacco or any other financial institution for more than Sixty days within two years prior to elections. And shall not have been declared bankrupt.
- (v) Must be working in a station within the electoral zone.
- (vi) Must be passing salary or Pension through the FOSA for at least for three months prior to the election date.
- (vii) The delegates shall serve for a period of three year but shall be eligible for re-election.
- (viii) Must have attained the minimum Share capital of Ksh 25,000 three months prior to the election date
